AN ORDINANCE OF ESCAMBIA COUNTY, FLORIDA REPEALING AND REPLACING VOLUME 1, CHAPTER 86, ARTICLE IV, DIVISION 2, OF THE ESCAMBIA COUNTY CODE OF ORDINANCES RELATING TO ROADWAY SAFETY; CREATING VOLUME 1, CHAPTER 86, ARTICLE IV, DIVISION 2, SECTIONS 86-106 THROUGH 86-112 RELATING TO PEDESTRIAN AND ROADWAY SAFETY; REPEALING VOLUME 1, CHAPTER 86, ARTICLE VIII, RELATING TO SOLICITING, BEGGING, AND PANHANDLING; REPEALING VOLUME 1, CHAPTER 94, ARTICLE III OF THE ESCAMBIA COUNTY CODE OF ORDINANCES RELATING TO PEDESTRIAN SAFETY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR AN EFFECTIVE DATE.

Notwithstanding the application of the exemption(s) noted above, or in the absence of any applicable exemption, the County hereby publishes the following information in accordance with the provisions of Section 125.66(3), Florida Statutes:

1. Summary of the proposed ordinance, including a statement of the public purpose, such as serving the public health, safety, morals, and welfare:

The proposed Ordinance is intended to prohibit activities that interfere with the purpose of public roads and rights-of-way by causing distractions to motorists, unsafe pedestrian movement within travel lanes, impediments to the orderly flow of traffic, dangerous traffic movement, increased vehicular accidents and pedestrian and motorist injuries and fatalities. The County has a significant government interest in promoting pedestrian and roadway safety and the free flow of traffic, and the regulations set forth in this Ordinance are the least restrictive means necessary to promote and protect the public health, safety, and general welfare of the County, its citizens and taxpayers, while leaving ample alternative avenues for the expression and exchange of thoughts and ideas.
