This Ordinance is enacted under the authority of Article VIII, Section 1(f) of the Constitution of the State of Florida and Chapter 125, Florida Statutes, for the purpose of providing for a street lighting district in certain unincorporated areas in Escambia County, Florida as described herein, not lying within the corporate boundaries of any municipality. The Board of County Commissioners (BCC) of Escambia County, Florida has the authority to establish a Municipal Service Benefit Unit ("MBSU") pursuant to Chapter 125, Florida Statutes. The owners of the property contained in the *Pine Top Subdivision* area have met the criteria established by the BCC for a MSBU, and the property owners wish to establish such a MSBU for the purpose of providing street lighting in this district.

No direct economic impact on private, for-profit businesses is anticipated as a result of the proposed Ordinance.
