AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF ESCAMBIA COUNTY, FLORIDA, AMENDING VOLUME 1, CHAPTER 18, ARTICLE VII, SECTIONS 18-354 THROUGH 18-355 OF THE ESCAMBIA COUNTY CODE OF ORDINANCES TITLED "REMOTE VEHICLE SALES"; PROVIDING A FISCAL IMPACT STATEMENT; PROVIDING FOR APPLICABILITY; PROVIDING FOR SEVERABILITY AND CONFLICTS; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.
