2. Specification Section 111900 Basic Detention Requirements
Change Paragraph 1.03 Submittals to the following:

1.03 SUBMITTALS:
 - A. Provide complete and detailed submittal package of all products in the DEC scope of work.
 - B. Submit a letter from the lock manufacturer stating that the DEC firm is a factory-trained, fully authorized installer of their complete line of product.
3. Delete Paragraph 1.04 Quality Assurance.
4. Question: Do you have the finish specs on the plastic laminate color(s) for the casework and countertops?

Answer: Plastic Laminate Colors have not been selected. Plastic Laminate Colors shall be selected from full range of manufacturer's standard colors.

5. Question: We have 3/4" painted plywood partitions from other jobs. May they be used for the temporary walls or must we build the temporary walls per the specs?

Answer: Temporary partitions shall be a one-hour fire rated UL Assembly, with fire retardant plywood on the occupied side as shown in detail 1/G002. The contractor may submit a substitution request of a different 1 hour fire rated UL Assembly for approval.
