This Addendum #3 provides for:

Revised Page 12 of Bid Form

Attached form replaces page 12 of the original solicitation and reflects a change in square footage for Hazardous House Waste building 251 from 8,250 sq. ft. to 280 sq. ft. and a change in total of square footage for Solid Waste from 21,901 sq. ft. to 13,931 sq. ft. **Note:** Building 30281 Guard Trailer will not need to be cleaned, but supplies, soap, and paper towels will need to be provided.

Responses to Questions:

1. Is it possible to get the current supply usages from the current contractor?
Response: Facilities Management does not collect that information and thus it is not available.
2. Are there any significant changes from the last bid?
Response: As with any bid, there are changes, but none of major significance.
3. What are the County's prevailing living wage rate? Can that be included in the bid spec?
Response: Prevailing wage is not part of this solicitation.
4. Is there collective bargain Agreement with the County or current vendor?
Response: No, there is no collective bargaining unit for this scope of work.
