The Owner and/or Owner's representative reserves the right to reject any bids submitted by firms without sufficient experience in projects of this size, complexity, or any other terms the Owner or Owner's representative may deem relevant. The Contractor shall have sole responsibility for the satisfactory execution of the work, even though he may have sub-contracted a portion of the work, or had certain manufacturers install their own products. The Awarded Contractor shall provide résumés of the project coordinator (manager) and lead installer planned to be used for this project.
