ELECTRICAL PERMIT APPLICATION

GENERAL INFORMATION:

PARCEL NUMBER: The Parcel Number can be obtained from the Escambia County Property Appraiser (www.escpa.org).

SRIA/TOWN OF CENTURY APPROVAL: If the project is located on Pensacola Beach or within the Town of Century prior approval is required. The approval is required to be submitted by the customer to this office when applying for a Building Permit. (Not applicable to the City of Pensacola.)

NOTICE OF COMMENCEMENT: The recorded Notice of Commencement is required if the project's cost of construction is \$2,500 or more. The form is to be completed, notarized, and recorded with the Escambia County Clerk of the Court. The recorded copy of the Notice of Commencement is to be submitted to the respective department before any inspections will be performed and a copy <u>must</u> be posted on the job site.

WARNING TO OWNER: YOUR FAILURE TO RECORD A NOTICE OF COMMENCEMENT MAY RESULT IN YOUR PAYING TWICE FOR IMPROVEMENTS TO YOUR PROPERTY. A NOTICE OF COMMENCEMENT MUST BE RECORDED AND POSTED ON THE JOB SITE BEFORE THE FIRST INSPECTION. IF YOU INTEND TO OBTAIN FINANCING, CONSULT WITH YOUR LENDER OR AN ATTORNEY BEFORE COMMENCING WORK OR RECORDING YOUR NOTICE OF COMMENCEMENT.

ELECTRICAL PROJECTS LOCATED WITHIN A SPECIAL FLOOD HAZARD AREA:

The following is the minimum standard for structures located in a Special Flood Hazard Area (SFHA) requiring a permit in Escambia County and the City of Pensacola. The following sets the maximum number of electrical devices allowed below site specific base flood elevation (BFE).

Flood requirements enforced by local jurisdictions in Florida are based on the Florida Building Code (FBC), National Flood Insurance Program (NFIP) and the established local floodplain requirements. The 8th edition of the FBC references ASCE 24 for regulation of enclosures below the base flood elevation as noted below.


Based on the referenced regulations the minimum number of electrical devices allowed below the BFE are as follows:

- One electrical outlet on the interior of each exterior wall.
- One front exterior outlet.
- One rear exterior outlet.
- One light switch at each stairway or entryway.

All electrical services below BFE must be provided on a ground-fault interrupt circuit (GFCI) separate from other circuits in the building.
