## NOTICE OF COMMENCEMENT RECORDING GUIDELINES

Florida Statutes Section 713.13 requires that prior to commencing any improvement to real property for which the direct contract price is greater than \$5,000.00, or the direct contract price is greater than \$15,000.00 for the repair or replacement of existing heating or air-conditioning systems, the owner or owner's agent (contractor) must record a Notice of Commencement with the jurisdiction. The Notice of Commencement is required to be signed by the owner. Escambia County Building Services will not perform or approve inspections until a certified copy of the Recorded Notice of Commencement has been provided by the Owner or Owner's Agent.

The Recorded Notice of Commencement's has an expiration date that is one year from the date of the recording.

If the contracted improvement is not commenced within ninety (90) days of the recording, then the Notice of Commencement is void.
