### A. CALL TO ORDER / PLEDGE / INVOCATION -

Chairman Parker called the meeting to order. Commissioner Barry led the pledge and Chairman Parker led the prayer. Chairman Parker stated that a quorum was not present and that they would proceed with the meeting without action.

### B. APPROVAL OF AGENDA

Ms. Washnock stated that an item needed to be added under Enclosure D and that Enclosure B needed to be pulled.

### C. PUBLIC FORUM

Mr. James Gulley stated that he attended the U.S. 90 (West Cervantes Street) Pedestrian Safety Improvements public hearing that was held last night at the Fricker Community Center. Mr. Gulley stated that the citizens of West Cervantes are not happy and that FDOT under estimated the grid in that area.

Ms. Hill asked what the procedure would be if the citizens oppose the design recommended by FDOT. Ms. Hill asked if she could meet with Mr. Mount and ECRC staff to see what steps would need to be taken to make the road diet. Mr. Mount agreed. Mr. Mount stated that the interim safety improvements are an actual project that will be delivered, and the road diet is still in concept stage. Mr. Mount stated if the board chose to make the road diet an actual project, it would need to be put into the LRTP and prioritize it to compete for funding.

### D. FDOT/ALDOT UPDATES:

1. FDOT UPDATE Mr. Bryant Paulk, AICP, or Ms. Christy Johnson, AICP, Florida Department of Transportation (FDOT) Urban Liaisons.

Mr. Paulk updated the board on the U.S. 90 (West Cervantes Street) Pedestrian Safety Improvements project. He provided a flyer to the board that was distributed at the public hearing. Mr. Paulk stated that FDOT anticipated accepting bids on the project in August 2020 with construction complete in early spring of 2022. Mr. Paulk stated that FDOT has worked closely with the City of Pensacola and Escambia County and the citizens groups along the corridor and have made many changes from the initial concept. Mr. Paulk stated that all the improvements together will produce a much safer corridor.

# 2. ALDOT UPDATE Mr. Vincent Beebe, P.E., Alabama Department of Transportation (ALDOT)

Mr. Beebe gave an update on the SR-180 widening from Foley Beach Express to west of SR-181. He reported that utility relocations are on-going, drainage items is being installed, and that roadway widening work is under construction. Mr. Beebe stated that ALDOT is currently expecting to have the project complete December 2020.

Mr. Beebe also reported on the new road and bridge from SR-180 to Foley Beach Express. He stated that ALDOT is continuing to finalize design, obtain right-of-way, and obtain environmental permits and clearances. He stated that the project is expected to be let in 2 parts – one for the bridge portion, and the other for the roadway portion. Mr. Beebe concluded by stating the construction lettings are currently anticipated for early to mid-2020. Mr. Paulk stated the FDOT is committed to continuing improvements along the corridor as the TPO prioritizes it.

**ORIGIN OF SUBJECT:** Federal Transportation Legislation (MAP-21 (Moving Ahead for Progress in the 21<sup>st</sup> Century) Act and FAST (Fixing America's Surface Transportation) Act), Federal Highway Administration, and Alabama and Florida Departments of Transportation

#### LOCAL GOVERNMENT ACTION NEEDED: None.

BACKGROUND: Annually, Transportation Planning Organizations (TPOs) are required to adopt targets for Safety Performance Measures by February 27. Since the Florida-Alabama TPO Planning Boundary crosses state lines, the TPO must plan and program projects to contribute towards separate targets—one set for each State in which the planning area boundary extends state lines. The TPOs can either accept the DOT targets or establish their own targets (see requirements in the next paragraph). In 2018 and 2019, the Florida-Alabama TPO accepted the DOT targets for Safety Performance Measures by adopting Resolutions FL-AL 18-01 and FL-AL 19-01. The necessary language for Safety Performance Measures was incorporated into the FY 2020-2024 Transportation Improvement Program (TIP) and amendments to the TIP and the 2040 Long Range Transportation Plan. This same procedure will be followed in 2020. Lastly, please note the targets for Bridge, Pavement, and System Performance were adopted by Resolution 18-24 on September 12, 2018 do not need to be adopted again by the TPO until April 1, 2023.

#### If a TPO agrees to support a State Highway Improvement Program Target, the TPO would

- Work with state and safety stakeholders to address areas of concern for fatalities or serious injuries within the metropolitan planning area.
- Coordinate with the State and include the safety performance measures and the State's Highway Improvement Program targets for those measures in the Metropolitan Transportation Plan.
- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect of the Transportation Improvement Program toward achieving Highway Safety Improvement Program targets in the Metropolitan Transportation Plan, linking investment priorities in the Transportation Improvement Program to those safety targets.

#### If a TPO establishes its own Safety Performance Target, the TPO would

- Establish Highway Safety Improvement Program targets for all public roads in the metropolitan planning area in coordination with the State.
- Estimate vehicle miles traveled (VMT) for all public roads within the metropolitan planning area for rate targets.
- Coordinate with the state and include the safety performance measures and the TPO's safety targets for those measures in the Metropolitan Transportation Plan.
- Integrate into the metropolitan transportation planning process, the safety goals, objectives, performance measures and targets described in other State safety transportation plans and processes such as applicable portions of the Highway Safety Improvement Program, including the Strategic Highway Safety Plan.
- Include a description in the Transportation Improvement Program of the anticipated effect of the Transportation Improvement Program toward achieving Highway Safety Improvement Program targets in the Metropolitan Transportation Plan, linking investment priorities in the Transportation Improvement Program to those safety targets.

The Florida Department of Transportation has adopted a "Vision Zero" target for the five safety measures. This "Vision Zero" target is based on the Florida Strategic Highway Safety Plan. The Alabama Department of Transportation has a "Toward Zero Death Initiative." The table below illustrates the targets the TPO adopted in FL-AL TPO FEBRUARY 2020 AGENDA

2018 and 2019 as well as DOT targets for 2020. The targets are based on a five-year rolling average.2018 (2012-2016), 2019 (2013-2017), and 2020 (2014-2018). At the December TPO and Advisory Committees, it was mentioned that if there was a desire to set targets for Safety which are different from FDOT and ALDOT, please e-mail Gary Kramer of the ECRC by December 18, 2019. No e-mails were received regarding the setting of targets different than the DOT targets by December 18, 2019. Lastly, FHWA, FDOT, and ALDOT indicated their satisfaction with this agenda item and no comments were necessary.

#### **FDOT's METHODOLOGY**

Florida shares the national traffic safety vision "Toward Zero Deaths," and formally adopted their own version of the national vision, "Driving Down Fatalities." FDOT is committed to eliminating fatalities and reducing serious injuries with the understanding that the death of any person is unacceptable and based on that, zero deaths is the FDOT safety performance target. This target is consistent throughout the FDOT Strategic Highway Safety Plan, Highway Safety Improvement Program and Highway Safety Plan.

#### **Number of Fatalities**

Based on statistical forecasting, the five-year rolling average for total fatalities on Florida's roads is forecasted to be between 2.877 and 3.175 in 2020. This forecast was made by combining Fatality Analysis Reporting System data with current state data from 2009 to 2018 to predict probable outcomes for 2019 and 2020. Florida's target for fatalities is zero in 2020. While the data forecast indicates Florida's five-year rolling average for fatalities could continue to trend upward in 2019 and 2020, the FDOT State Safety Office expects the projects chosen for funding will mitigate the data forecast and ultimately reduce the number of traffic fatalities.

#### **Number of Serious Injuries**

Based on statistical forecasting, the five-year rolling average for serious injuries on Florida's roads is forecasted to be between 17,480 and 19,123 in 2020. This forecast was made by combining Fatality Analysis Reporting System data with current state data from 2009 to 2018 to predict probable outcomes for 2019 and 2020. Florida's target for serious injuries is zero in 2020. The data forecast indicates Florida's five-year rolling average of serious injuries will continue to trend downward in 2019 and 2020. The FDOT State Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries on Florida's roads.

#### **Fatality Rate**

Based on statistical forecasting, the five-year rolling average for fatality rate per 100 million Vehicle Miles Traveled on Florida's roads in forecasted to be between 1.10 and 1.60 in 2020. This forecast was made by combining Fatality Analysis Report System data with current state data from 2009 to 2018 to predict probable outcomes for 2019 and 2020. Florida's target for fatality rate per 100 million vehicle miles traveld.is zero in 2020. While data forecast indicates Florida's fatality rate per 100 million Vehicle Miles Traveled will trend downward in 2019 and 2020, the FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend and ultimately reduce the fatality rate per 100 million Vehicle Miles Traveled.

#### Serious Injury Rate

Based on statistical forecasting, the five-year rolling average for serious injury rate per 100 million Vehicle Miles Traveled on Florida's roads is forecasted to be between 6.82 and 9.44 in 2020. This forecast was made by using current state data from 2007 to 2017 to predict probable outcomes for 2019 and 2020. Florida's target for serious injury rate per 100 million Vehicle Miles Traveled is zero in 2020. While the data forecast indicates Florida's serious injury rate per 100 million Vehicle Miles Traveled could continue to trend downward in 2019 and 2020, the FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of serious injuries on Florida's roads.

#### **Total Number of Non-Motorized Fatalities and Serious Injuries**

Based on statistical forecasting, number of non-motorized fatalities and serious injuries on Florida's roads is forecasted to be between 2,929 and 3,283 in 2020. This forecast was made by combining Fatality Analysis Report System data with current state data from 2007 to 2018 to predict probable outcomes for 2019 and 2020. Florida's target for number of non-motorized fatalities and serious injuries is zero in 2020. While the data forecast indicates Florida's number of non-motorized fatalities and serious injuries could continue to trend downward in 2019 and 2020, the FDOT State Safety Office expects the projects chosen for funding will enhance this downward trend in the number of pedestrian fatalities.

#### **ALDOT's METHODOLOGY**

#### **Number of Fatalities**

This performance target was developed through a trend line analysis of the five-year moving average for fatalities, Alabama unemployment rate trend, and Alabama Gross Domestic Product (GDP) trend. This analysis determined the 5-year moving average plus a 1.7% increase associated with increasing GDP correlated with the currently observed trend of fatalities in Alabama. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term fatality trends.

#### **Number of Serious Injuries**

This performance target was developed through a trend line analysis of the five-year moving average for serious injuries, Alabama unemployment rate trend, and Alabama Gross Domestic Product (GDP) trend. This analysis determined the 5-year moving average plus a 1.7% increase associated with increasing GDP correlated with the currently observed trends of serious injuries in Alabama. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term serious injury trends.

#### **Fatality Rate**

This performance target was developed using the fatalities and an estimated 1% growth in Vehicle Miles Traveled (VMT) from the previous year. This target represents the projected serious injuries as a ratio of 100 million VMT. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce serious injury rate trends.

#### **Serious Injury Rate**

This performance target was developed using the fatalities and an estimated 1% growth in vehicle miles traveled (VMT) growth of 1%. The target represents the projected serious injuries as a ratio to 100 million VMT. This target supports the Highway Safety Improvement Plan by helping Alabama focus its strategy, or direction, and making decisions on allocating its resources to reduce long-term serious injury rate trends.

#### **Number of Non-Motorized Fatalities and Serious Injuries**

This performance target was developed through a trend line analysis of the five-year moving average for non-motorized fatalities and serious injuries, Alabama unemployment rate trend, and Alabama Gross Domestic Product (GDP) trend. This analysis determined the non-motorized fatalities and serious injuries 5-year moving average plus a 1.7% increase associated with GDP correlated with the currently observed trend of non-motorized fatalities and serious injuries. This target supports the Strategic Highway Safety Plan by helping Alabama focus its strategy, investment, and making decisions on allocating its resources to reduce long-term non-motorized fatalities and serious injuries trends.

- Rate of Fatalities per Hundred Million Vehicle Miles Traveled Florida: "0" to support FDOT's 0 target for traffic fatalities per Hundred Million Vehicle Miles Traveled and support FDOT's "Vision Zero."   Alabama: "11.080" to support ALDOT's 11.080 target, which is a 5-year rolling average for the rate of serious injuries per Hundred Vehicle Miles Traveled, and support ALDOT's "Towards Zero Deaths Initiative."
- Number of Non-Motorized Fatalities and Non-Motorized Serious Injuries Florida: "0" to support FDOT's 0 target for non-motorized fatalities and non-motorized serious injuries and support FDOT's "Vision Zero."

  Alabama: "384" to support ALDOT's 394 target, which is a 5-year rolling average for non-motorized fatalities and non-motorized injuries, and support ALDOT's "Towards Zero Death Initiative."

#### A. Introductions and Welcome

- Gary Kramer welcomed the participants to the Steering Committee Meeting for the 2045 Florida-Alabama Transportation Planning Organization (TPO) Long Range Transportation Plan. Each of the participants stated their names and the organization they represent.
- Chairman Powell requested Gary Kramer and Cory Wilkinson to present the items on the agenda.

#### B. Update on the Process and Schedule

- Gary Kramer mentioned the Goals and Objectives were adopted by the Florida-Alabama Transportation Planning Organization on July 10, 2019. The Draft Goals and Objectives Technical Report has been sent to the Review Agencies with comments requested by the close of business on Wednesday September 25, 2019.
- Gary Kramer stated the development of the Needs Plan and the Congestion Management Process will be the next tasks that be requested for input from the Steering Committee.
- Gary Kramer iterated that 2040 Long Range Transportation Plan was adopted on November 3, 2015. The 2045
  Long Range Transportation Plan needs to be adopted by November 3, 2020 to maintain the 5-year requirement
  between Long Range Transportation Plan Updates.

- Gary Kramer said the Evaluation Criteria is derived from the Adopted Goals and Objectives and is used to rank the Needs Plan projects.
- Cory Wilkinson reviewed the approach for developing the draft 2045 Long Range Transportation Evaluation Criteria.
- Cory Wilkinson emphasized the 2045 Goals and Objectives were reviewed with the 2040 Evaluation Criteria for a starting point for updating the 2045 Evaluation Criteria.

As a result, points were only assigned values from 0 to 1, or 0, 0.5, or 1. This was presented in a comparison table for 2040 Long Range Transportation Plan Evaluation Criteria with 2045 Long Range Transportation Evaluation Criteria. The recommended changes were highlighted.
- The discussion by the Steering Committee Members for recommended changes were as follows:
  - Spell out the abbreviations and acronyms.
  - Move "Adopted Plans" from User's Needs to Operational and Integrated, and consolidate it with Corridor and Freight Plans.
  - Leave Level of Service and Volume to Capacity Ratios in the Evaluation Criteria instead of percent of delay on corridors and intersections.
  - Use Federal Functional Classifications instead of Local, County/State, and US Highway Classifications for "Connectivity."
  - Move the Weights for "Operational and Integrated" from 20 to 15 and "Planning" from 5 to 10 as identified in the 2040 Evaluation Criteria.
  - o Include Pedestrian, Bicycle, and Public Transportation as one category instead of three separate categories.
  - o Include "Complete Streets" as a criterion. Cory Wilkinson will discuss this suggestion with other HDR Staff and try to develop a criterion for review at the next Steering Committee Meeting.

#### D. Financial Resources

- Cory Wilkinson reviewed the Florida Department of Transportation 2045 Revenue Forecast and presented a Financial Resources PowerPoint.
- Gary Kramer said the present-day Revenue Estimates will need to be inflated to Year of Expenditure when developing the 2045 Cost Feasible Plan.
- Bryant Paulk mentioned the Strategic Intermodal System revenue estimates for Florida Department of Transportation will be provided by Ray Kirkland.
- Cory Wilkinson iterated that Alabama Department of Transportation will be providing their revenue estimates to Gary Kramer.
- Cory Wilkinson stated that the local governments will be contacted to determine if any capacity projects will be funded locally.
- Andrea Levitt Kvech requested the aviation, rail, intermodal access, seaports, and SUN Trail funding sources listed in the statewide estimates be listed in the Alternative Revenue Sources.

**ORIGIN OF SUBJECT:** Fixing America's Surface Transportation (FAST) Act § 1109; 23 U.S.C. 133(h); FDOT; and Task C.4 of the Unified Planning Work Program (UPWP)

#### LOCAL GOVERNMENT ACTION NEEDED: None.

**BACKGROUND**: The Transportation Alternatives (TA) Set-Aside provides funding for programs and projects consistent with Fixing America's Surface Transportation (FAST) Act under 23 U.S.C. 133(h). These set-aside funds include all projects and activities defined as TA: On- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation, community improvement activities, environmental mitigation and projects for planning, designing or constructing boulevards and other roadways largely in the right-of-way of formerly divided highways.

Scoring Criteria Update: In anticipation of the FDOT District 3 TA grant application solicitation in the Fall of 2019, TPO staff provided an opportunity for the FL-AL TPO Technical Coordinating Committee (TCC) members to provide input on the current scoring criteria content and procedures at a public workshop on May 22, 2019. Public input was collected until June 17, 2019. No changes were suggested during the public comment period. No significant changes were made to the content of the criteria. At the July 10, 2019 FL-AL TPO meeting, Resolution FL 19-14 was approved adopting the updated TA Scoring Criteria.

<u>Education Workshop</u>: The FL-AL TPO sponsored a TA Education Workshop on Thursday, October 24, 2019, from 11:00 – noon at Pensacola City Hall, 222 w. Main Street. The purpose of this workshop was to review the previously approved TPO criteria and receive FDOT guidance on the application documents.

<u>FDOT Guidance</u>: FDOT District 3 issued guidance on the 2020 TA Set-Aside cycle for the Fiscal Year 2022 – 2026 Tentative Work Program on October 22, 2019. The guidance specified each TPO may submit up to two (2) priorities projects from each TPO area. Rural areas outside of the TPO area may submit applications directly to FDOT.

ECRC Review and Workshop: Applications eligible for submittal to ECRC were due December 13, 2019. Six (6) applications were received: two (2) from City of Pensacola, two (2) from Escambia County, one (1) from City of Milton, and one (1) from Santa Rosa County. Applications were reviewed by ECRC and the General Planning Consultant staff. An application review workshop was held on Wednesday, January 8, 2020, at the Emerald Coast Regional Council offices. Applications were reviewed and workshop participants agreed on the revised score and offered a recommended ranking.

<u>ECRC Submittal</u>: Following action by the TPO, applications are due to FDOT on February 28, 2020. TPO staff will submit all applications from the TPO to FDOT.

#### Pensacola


- Multi-Modal Connectivity to Legion Field Park and Global Learning Academy, Segment 1, L Street.

  Applicant (City of Pensacola Community Redevelopment Agency) is requesting \$951,787 for design, construction, and CE&I for construction of a 6-ft wide concrete sidewalk, sodded bump-out curbs, a 6-ft painted parking lane, wayfinding/bicycle signage, and pedestrian-level lighting (4 per block, on both sides of the road), on North L Street from Gregory Street to Cervantes Street (1 mile). This is a *yield street* design to achieve traffic calming and improve pedestrian and bicyclist safety (traffic shares the lane where intentional bump-outs accommodate sidewalk). No local match is proposed. However, if the project is awarded, the City will seek additional funds from other sources to support street trees/landscape improvements. FDOT notes the project is an applicable project that provides connectivity, and recognizes the unique "yield street" concept proposed for L Street. This project was the FL-AL TA #1 priority submittal for 2019, but was not selected based on the availability of funding and the competitiveness of other applications submitted. Additional phases are identified, but the current submittal is only for Segment 1, L Street. Total project cost estimated at \$1,871,972, segmenting project into prioritized phases: (1) Priority 1, L Street, \$951,787; (2) Priority 2, Gregory Street, \$698,204; and (3) Priority 3, Wright Street, \$221,982. ECRC workshop review recommends this project as #1 priority.
- Multi-Modal Connectivity to Downtown Pensacola via W. Main Street. Applicant (City of Pensacola Community Redevelopment Agency) is requesting \$426,488 for a 10-foot multimodal bike/ped side path (0.16 mi) located along West Main Street. The project was originally envisioned as a recommendation of the West Main Street Corridor Management Plan completed and adopted in 2014. The project will serve as a west extension to the Main Street road diet east of the project limits, and will provide for the conversion and re-use of an un-utilized segment of railway corridor for trails for pedestrians and bicyclists. Project includes pedestrian level lighting as well. Applicant indicates a 5% local match. FDOT notes this as an applicable project. This project was the FL-AL TA #2 priority submittal for 2019, but was not selected based on the availability of funding and the competitiveness of other applications.




#### Milton

• Multi-Modal Collector Ph1. Applicant is requesting \$192,330 for design, construction, and CEI, for bike-ped facility to provide network continuity from Milton (SR 87 / Stewart Street) to the Bagdad Mill Site Park and Village (Broad St) (approx. o.4 mille) as 8-ft multi-use trails, 5-ft sidewalks, 2 crosswalks and one bike-ped bridge. The city is providing local match of 10% for a total project cost of \$213,700. This is a multi-phase project, consisting of Phases I-V. Funds for Phase I are being requested. Phase I is from Stewart Street to Carpenter's Park. Phase I has two segments. The first segment begins at the intersection of Stewart Street and Munson Highway; from the existing sidewalk on the west side of Stewart Street to include a mid-block crosswalk that connects to Munson Highway. Five-ft sidewalks will then extend along the south side of Munson Highway to the Blackwater Heritage Trail. The second segment is an 8-ft multi-use trail that starts from the east side of the Blackwater Heritage Trail and diverts south to Broad Street with an 8-ft multi-use trail located on the west of Broad Street. This connects, with a crosswalk, to existing sidewalks on the east side of Broad Street at Carpenter's Park. The City will contribute a 10% monetary match. The City of Milton will need to secure Local Agency Program (LAP) project certification from FDOT if this project is selected for TA funding. ECRC workshop review recommends this project as #2 priority.



#### **Escambia County**

- Massachusetts Avenue Sidewalks. Applicant is requesting \$978,802 for design, construction, and CEI, for 5-ft sidewalk along both sides of Massachusetts Avenue (2.9 miles) from Mobile Highway to Erress Blvd.
   Project is highlighted in the 2018 Florida-Alabama TPO Pedestrian Bicycle Master Plan. No local match is proposed. This project was a previous TA project currently in Design from 2016.
- <u>Patricia Drive Sidewalks.</u> Applicant is requesting \$507,030 for design, construction, and CEI, for 5-ft sidewalk along the east side of Patricia Drive (0.9 miles) from SR 727 (Fairfield Drive), to Santa Barbara Street. No local match is proposed.



#### Santa Rosa County

Panhandle Trail Bike Lanes. Applicant is requesting \$1,553,777 design, construction, and CEI, for 70ft of bike lanes (5-ft bike with 2-ft buffer per updated standards) on both sides of Panhandle Trail from US 98 to East River Drive (approx. 1 mile). This project was previously submitted (FY16, FY17, FY18), but not selected for TA funding. Panhandle Trail is a north-south connector between US 98 and SR 87. The proposed improvements serve as a multimodal transportation link that will increase bicycle pedestrian safety and promote increased awareness. The Panhandle Trail bike lanes provide opportunity to make connections to Navarre High School, the YMCA and Navarre Sports Complex.

Currently, the road diet is not in the Long Range Transportation Plan (LRTP) or cost feasible and would need to be placed in the updated Long Range Transportation Plan (LRTP).

#### **LOCAL GOVERNMENT ACTION NEEDED:** None

**BACKGROUND:** The TPO updates the Long Range Transportation Plan every 5 years. The current LRTP was adopted on November 3, 2015. The 2045 Florida-Alabama LRTP's Scope of Services was approved by the TPO on February 13, 2019, and a Notice to Proceed issued on March 11, 2019. Some of the tasks identified in the LRTP Scope of Services are: Public Participation, Goals and Objectives, Evaluation Criteria, Financial Resources, Cost Feasible Plan, Congestion Management Process Update, and Needs Plan.

#### **Congestion Management Process**

The Congestion Management Process is completed as a task in the 2045 Long Range Transportation Plan development as a major update. The Congestion Management Process is required of TPOs with populations greater than 200,000. The Florida Department of Transportation has extended this requirement to all TPOs in Florida. The draft Congestion Management Process was sent to review agencies for comment on February 3, 2020 with comments requested by close of business on February 24, 2020.

The 2045 LRTP Plan Steering Committee met at Pensacola City Hall on the January 21<sup>st</sup>, 2020 to comment on Congestion Management Process and hear an update on the status of the Needs Plan.

#### C. Status of Evaluation Criteria and Financial Resources

Cory Wilkinson mentioned the Evaluation Criteria and the Financial Resources have been vetted by the Steering
Committee in the previous two meetings and will be presented to the TPO in February. The TCC and CAC
recommended approval at their December meetings. Once the TPO approves these items, the Technical Reports
will be produced.

#### D. Congestion Management Process

- Cory Wilkinson mentioned a task in the Long Range Transportation Plan is to produce a Congestion Management Process document. There are eight items a Congestion Management Process must include. These eight items are:
  - Develop regional objectives for congestion management.
  - Define the Congestion Management Process network.
  - Develop multimodal performance measures.
  - Collect data/monitor performance.
  - Analyze congestion problems and needs.
  - o Identify and assess strategies.
  - Program and implement strategies.
  - o Evaluate strategy effectiveness.
- The objectives and performance measures were reviewed with the Steering Committee and the following questions were asked.
  - What is rideOn? It a vanpool/carpool service provided by the Emerald Coast Regional Council that matches potential riders through a database.
  - o Replace ITS with an ATMS performance measure.
  - o Replace Accidents with Crashes.
  - o Include education to assist in reducing traffic and pedestrian facilities such as bringing hot spots to the Community Traffic Safety Team.
  - o A number for resurfacing projects will need to be agreed upon at the next steering committee meeting.
- Mike Ziarnek encouraged the Steering Committee Members to review the statewide report "Dangerous by Design" and reminded participants that vehicular Level of Service is not a good evaluation measure for urban transportation/complete streets consideration.
- Barbara Mayall stated that adequate infrastructure should be installed prior to a roadway being resurfaced. She
  also questioned if construction of the new school had bearing on the Strategic Intermodal System (SIS) designation
  of US 98.
- Gary Kramer added the Congestion Management Process is required for TPOs with a population greater than 200,000 in federal law. FDOT has also required that all TPOs in Florida develop a Congestion Management Process. The Florida-Alabama TPO does a major update to the Congestion Management Process in conjunction with the Long Range Transportation Plan. A minor update to the Congestion Management Process is done annually.

#### E. Needs Plan

- Cory Wilkinson said the Needs Plan is a list of transportation projects that are needed by 2045 regardless of funding. A list of deficiencies will be created by running the regional transportation model with the 2045 socioeconomic data and an existing plus committed transportation network. These deficiencies and other needed projects by mode will be reviewed and commented by the Steering Committee. Public Meetings, and the TPO and Advisory Committee Meetings.
- Updates on the Freight, Pensacola International Airport, and Port of Pensacola were presented.

#### **Freight**

- o Rickey Fitzgerald reviewed a PowerPoint on Freight for FDOT District III and the Florida-Alabama TPO.
- The Freight Mobility and Trade Plan is almost complete and includes an investment plan for use of federal National Highway Freight Program (NHFP) funding.
- In FDOT District III, there are 42 capacity projects, 4 ITS projects, 2 Feasibility Study Projects, and 1 Truck
   Parking Project. The highest ranked projects in the Florida-Alabama TPO area:
  - I-10 at US 29 Interchange
  - I-10 at Nine Mile Road Interchange
  - I-10 from East of Alabama State Line to West of US 29
- The top challenges statewide are:
  - Congestion/Bottlenecks
  - Truck Parking
  - Empty Backhaul
- Hotspots for Level of Service, Pavement Condition, Bridges, Safety, and Truck Parking were also shown via statewide maps.

#### Pensacola International Airport

- Andrea Levitt Kvech stated the airport priorities are submitted to the TPO annually. A Master Plan has been recently completed and is waiting Federal Aviation Administration acceptance.
- The major priorities are parking, terminal, and airfield improvements.
- A second hangar off Merlion Way should start design in April. Maintenance Repair, and Overhaul expansion across from Pensacola State College is also in discussion.

#### Port of Pensacola

- Clark Merritt from Port Pensacola submitted a list of improvements for the 2045 Long Range Transportation Plan Needs Plan in an e-mail prior to the Steering Committee Meeting. A Master Plan has been completed by the Port of Pensacola. The improvements outside the gate that need to be considered for the Needs Plan are:
  - Port Main Gate Relocation
  - Cedar and Tarragona Street Improvements
  - Main and Barrancas Street Improvements
  - Access to/from I-110 for port freight improvements

#### F. Comments from Committee Members and Public

No further comments were provided by neither the Committee Members nor the public.

#### G. Next Steps

- Gary Kramer iterated the Evaluation Criteria and Financial Resources will an action item for the TPO in February.
  The Congestion Management Process will be a review item at the February TPO and Advisory Committees with a
  recommended action at their April Meetings. An update on the Needs Plan process will be presented at the
  February TPO and Advisory Committee Meetings with review at their April Meetings, and a recommended action at
  their June Meetings.
- Gary Kramer added the next Steering Committee Meeting will focus on a recommendation for Congestion
  Management Process with majority of the meeting focusing on development of the Needs Plan. Presentations
  from Pensacola Naval Air Station, Whiting Field, Escambia County Area Transit, and Baldwin Regional Area Transit
  System will also be part of the next Steering Committee Meeting.
