To all of Escambia County,

As we mark the two-year anniversary of the April 29, 2014 flood, I am sure you vividly remember the unprecedented damage to private and public property as 22 inches of rain fell within 29 hours. I am still amazed that our public works crews removed more than 280 tons of debris and pumped one million gallons of water out of neighborhoods. Estimates of damage to county infrastructure and buildings were an astounding \$89 million - and counting. With such staggering destruction, recovery is neither fast nor easy; it must be a strategic, multi-year commitment.



As you read through this transportation and drainage recovery report, you will see that in the two years since the floods, we have made significant progress in our recovery. Out of 182 identified stormwater improvement or repair projects, 82 percent are complete. Thanks to efforts of our Stormwater Advisory Team, staff, and the direction of the commission we have made significant strides in our long-term goal of improving how our county can withstand the impact of similar events in the future. It meant looking at and continuing to focus on stormwater as a whole instead of piecemeal plans from development to development, and going through the difficult process of establishing a new standard in how we do things in Escambia.

Recovery is costly. On pages six through eight, you will find information on the many programs we are leveraging to help fund the 2,300 identified locations with infrastructure damage. Many of the 182 resulting projects are designed not only to repair flood damage, but help solve long-standing issues found in the communities prior to the flooding.

While we have made significant progress, we are not yet fully recovered. We have 32 projects that are currently funded and in the design or construction phase. Although a viable temporary bridge on South Old Corry Road Bridge has been constructed, the permanent replacement project is not yet funded. The Transportation Planning Organization has asked the Florida Department of Transportation to place the project on their Bridge Replacement Funding and Prioritization Program. If approved, the project is estimated at \$2.6 million to construct, with the county's share being approximately \$650,000. In the Lake Charlene area, we have applied for a \$2 million Hazard Mitigation Grant and a draft agreement with the Florida Department of Emergency Management is currently under review to improve the Lake Charlene outfall capacity. This project is expected to improve flooding by more than 90 percent when complete. A secondary outfall for the Bridle Trail lake area is also planned with alternate funding.

Where this report only focuses on transportation and drainage projects, I would be remiss if I did not note that replacing our central booking facility and jail is a significant marker of our recovery. It is an immense project and one we all wish could move at a quicker pace. However, we are making progress each day.

While we can never take away the suffering our residents endured as a result of this natural disaster, we can continue to identify and invest in solutions to reduce the threat of flooding and protect our citizens.






## April 2014 Floods


April 29 and 30, some areas of Escambia County received as much as 22 inches of rain in a 29 hour period, making it fall between a 100 or 200 year event. The terms "100 year" and "200 year" floods are used to describe the estimated probability of a flood event happening in any given year. Their primary use is for determining flood insurance rates in flood hazard areas. A 100 year event has a one percent probability of happening in a year and a 200 year event a .5 percent probability. It is possible to have two 100 or even 500 year floods within years or months of each other.

Teams from Escambia County immediately began to address public safety concerns, emergency contracting, coordinating with other agencies, and the monumental task of conducting damage assessments. To accomplish this, the county was divided into 13 manageable areas based on population and development and two person teams were







mobilized to survey damage in their assigned zones. Assessments of homes, businesses and county facilities and infrastructures like roadways, bridges, drainage systems, and ponds yielded more than 2,300 damage points in the county. Using this system, a majority of the county was assessed in five days. In the following pages of this report, you will find an update on the damage to county infrastructure which resulted in 182 projects amounting to approximately \$25.8 million in design and construction costs.

Once recovery was on its way, goals next turned to reforming the county's stormwater policy. The Escambia Board of County Commissioners established the Stormwater Advisory Team, or SWAT, in conjunction with the City of Pensacola. This team was tasked to give a "fresh look" at stormwater standards through public involvement and discussion. The SWAT was made up of a variety of individuals and professionals; not government staff, engineers, or politicians. Major topics of meetings included storm damage from the April 2014 flooding, precipitation data, low impact design, intergovernmental cooperation, the Pensacola Bay Basin, South Old Corry Bridge and the Lake Charlene area.

The results were two reports that outlined multiple suggested actions for improvements, including the **Stormwater Needs Assessment** and the **SWAT County-Wide Stormwater Recommendation Report**. On April 16, 2015, the Escambia County Board of County Commissioners implemented the recommendation to revise the storm standards from a 25 year event to a 100 year event. Staff have also developed a "low impact design manual," a site design approach that utilizes Green Infrastructure to meet a project's post development stormwater runoff water quality requirements.






## Recovery-Summary-

Damage caused by the overwhelming April 2014 floods to Escambia County infrastructure, parks, facilities and private property was significant. During the second year of recovery county staff and construction crews have continued moving aggressively to repair damages and make needed improvements.

Work to meet the repair needs of the county is still ongoing, and much has been accomplished. The county continues to work with several federal agencies that provide reimbursement funding following a declared disaster. Damage to county infrastructure has resulted in 182 projects with an approximated cost of \$25.8 million for design and construction. These projects are located throughout the southern half of Escambia County, not including damages in the Pensacola city limits.

### **Project Funding**


- Eligible projects are submitted for 75 87.5 percent federal and state reimbursement (see next page).
- Six grant programs are also being explored which will supplement the county's LOST, or local option sales tax, dollars for future projects, see page 7 for more details.
- There are four projects currently underway that were not eligible for grant funding and are funded by LOST dollars. Those projects are Ponderosa Drive Pond, Mayfair/Algiers, Willowbrook Lake and Colonade Circle & Devonshire Circle Drainage Improvements.

# Status-of-Damages, Costs & Reimbursements

The April 2014 storm left over 2,300 infrastructure damage locations, resulting in 182 combined projects. The status of all of the damage locations are as follows: received permanent repair, temporary repair, under construction or in the design or procurement phase.

The county is exploring a wide variety of funding options to help with the \$25.8 million in projects planned to complete infrastructure repairs and mitigation. A large portion, or approximately \$20.15 million, is currently projected to be reimbursed from:

- The Natural Resources Conservation Service reimbursed at 75 percent per approved project
- The Federal Highway Administration reimbursed at 80 percent per approved project
- FEMA reimbursed at 75 percent by FEMA and 12.5 percent by the Florida Division of Emergency Management

## Schedule-for-Ongoing-Repairs-

In taking a look at the schedule for the 32 ongoing repair projects, here is the list of remaining projects to be completed. These projects total \$13.2 million, \$11.2 million is expected to be reimbursable costs from federal and state agencies and \$2 million in local option sales tax.

## Addressing-Other-Flooded-Areas-

Most discussions regarding the April 2014 storm repair efforts were centered on areas with infrastructure damage caused by the storm. This is due to damages to infrastructure being eligible for disaster grant funding and subject to the grant agency timelines. There are several areas of the county where flooding occurred without obvious infrastructure damage. The county documented locations and is pursuing other avenues for funding.

Some of the funding sources and projects include:

## **FEMA Hazard Mitigation Grant Program**

The county has submitted grant applications for five HMGP project and one Global Match project worth over \$17.4 million. The grant program has a 25 percent match requirement that can be either paid out of LOST or by other money being spent to provide flood reduction for the county. The county has submitted a global match project that, if approved, would cover the match costs, essentially covering all costs for the five projects at no additional expense to the county. The HMGP projects

were reviewed by the State and are currently under review by FEMA with an expected status update due in the Spring/Summer 2016. Upon FEMA approval, projects will transition into the design phase.

### **RESTORE & The Nature Conservancy**

TNC facilitated a community-based watershed planning process along Florida's Gulf Coast for six watersheds, including Perdido Bay and Pensacola Bay. The process was designed to provide a screening tool for communities, Florida Department of Environmental Protection, Florida Fish and Wildlife Conservation Commission, National Fish and Wildlife Foundation and the Gulf Coast Restoration Council to evaluate the watershed project priorities for potential RESTORE funding. The project list developed was used to pursue project funding for grant programs by documenting needs in the context of how they address solutions to the critical watershed issues.

## RESTORE & National Fish and Wildlife Foundation

The goal is to remedy harm and eliminate or reduce the risk of future harm to the Gulf Coast Natural Resources.
