	<p>Escambia County Land Development Code - Sec. 4-7.5 Alcoholic beverage sales. (a) Zoning compliance. Regardless of the sale of liquor, beer or wine as may be permitted by the applicable zoning district, no vendor shall sell alcoholic beverages, whether for on-premises or off-premises consumption, within 1000 feet of a place of worship, child care facility or K-12 educational facility, except as may be allowed by the provisions of this section. This prohibition does not apply to 1APS (beer only) or 2APS (beer and wine only) licenses, or to ODP (one, two or three-day) temporary permits, as described in Florida Statutes.</p> <p>This verification relates to zoning for the specified property and is provided for information purposes only. (b) Measurement. The distance required between the place of business selling alcoholic beverages and a place of worship, child care facility, or K-12 educational facility shall be measured along the shortest route of ordinary pedestrian travel within public rights-of-way, from the main entrance of the place of business to the main entrance of the place of worship or child care facility; or for an educational facility, to the nearest point of the grounds in use as part of the facility.
