FACILITY RULES & REGULATIONS

Event Producers – please ensure that your exhibitors are informed about the facility rules & regulations.

- 1. Site selection is first come, first served. Reservations may be made up to 45 days in advance only with advanced payment. The County reserves the right to vacate RV lots for special events, emergency operations, or other reasons not noted above with 24 hour notice.
- 2. With a minimum of 24 hour notice, pre-paid reservations will be fully refunded.
- 3. Parking is not allowed on the main road. Extra vehicles must be parked in parking areas.
- 4. No more than eight (8) campers are permitted per RV Lot. Additional sites must be rented to accommodate groups of over 8 persons. Every effort will be made to place large groups adjacent to each other, but is not guaranteed.
- 5. Escambia County and staff are not responsible for accidents or damage to any recreational vehicle or to any other vehicle, equipment or item in RV lots or on facility grounds.
- Campfires are only allowed in portable fire pits that campers bring with them. Campers are required to bring their own firewood and are not permitted to gather firewood from the facility's wooded areas.
- 7. The period between 10:00 p.m. and 6:00 a.m. is designated as quiet time. All activities during this time shall be carried out with respect to others right to rest. Campers making too much noise during this time will be asked to leave the premises.
- 8. Washing vehicles in RV lots is strictly prohibited.
- Pets are allowed but must remain under owners control and on a leash at all times. Violators will
 be asked to leave the campground or remove the animals from the camping area. You must
 clean up behind your pets.
- 10. The sanitary dump is free to persons renting RV sites. Other users subject to a \$10.00 charge.
- 11. Camping is allowed in designated RV sites only. Litter barrels are provided and it is requested that the campers use them to help keep the facilities clean.
- 12. Children 17 and under shall have an adult guardian on the premises at all times.
- 13. Campers must check in at the Equestrian Center Office or, in the event of a show, with the designated show contact in charge of RV sites.
- 14. Alcoholic beverages prohibited. See County Ordinance 97-15 Section 1-22-26 Sub 6.

- 15. Non-living quarters horse trailers are to be parked at appropriate locations to the east of the barns or to the southwest of the arena, not at RV sites. Horses are not permitted to overnight in trailers or anywhere in the RV sites or woods.
- 16. RV sites must be kept clean and orderly. Units and other temporary site structures must be cleaned.
- 17. Each individual is responsible for leaving the facilities in clean condition after use.
- 18. Storage of materials not normally associated with camping is prohibited. Items allowed should not detract from the overall appearance of the site. Equestrian Center manager has authority to determine if item(s) need to be removed.
- 19. Free standing sites are to be determined by Equestrian Center Staff.
- 20. Horses are not permitted in campsites. All horses staying overnight at facility must be stalled. Tie-outs, trailer stalling, and portable pens are not permitted.
- 21. Any trailer or vehicle plugging into electric anywhere on the facility will be considered to be camping and will be charged the standard RV rate of \$18 + tax.
- 22. The Equestrian Center manager has authority to enforce all Rules, Regulations and Policies.
