a) **Question**

How many of each service were performed in 2015?

**Response**

**Shed Clean-Out Services:**

The County currently requests three Shed Clean-Outs per year. Amounts will vary from 40 to 50 drums and four to six Gaylord boxes/Lab Packs

**Full Amnesty Day Event:**

Five events per year

b) **Question**

How many cars or residents attended the most recent full amnesty day event?

**Response**

Usually 400 to 500 participants show up for the event. Last event, there were 240 cars.

c) **Question**

Will the county modify the requirement on page 26 of the solicitation under Experience to read "...and have a permitted transfer, storage and disposal facility." This is as opposed to the restriction of having the TSD facility only within the State of Florida. We currently successfully service several counties within Florida with requirements similar or virtually identical to yours without this requirement and will happily provide references to document this.

**Response**  
**Experience**

The Contractor shall have successfully conducted a minimum of ten (10) Household Chemical Collections within the past four (4) years and have a permitted transfer, storage and disposal facility in the ~~State of Florida~~ United States. The events must be documented and verifiable. Also, the Contractor shall have experience responding to haz-mat emergency events.
