A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ESCAMBIA COUNTY, FLORIDA ESTABLISHING CERTAIN INSURANCE REQUIREMENTS FOR ESCAMBIA COUNTY'S SOLID WASTE MANAGEMENT PERMIT HOLDERS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Escambia County, Florida, has determined that it is necessary and in the best interest of the public to establish insurance requirements for Escambia County Solid Waste Management Permit holders; and,

WHEREAS, pursuant to the authority of Section 82-103 of the Escambia County Code of Ordinances, the Board of County Commissioners has the authority and responsibility to set by resolution insurance requirements for Solid Waste Management permits; and,

WHEREAS, the Board of County Commissioners has determined that insurance requirements set forth for permit holders be effective upon September 7, 2006 and shall supersede all other previous resolutions relating to said insurance requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ESCAMBIA COUNTY, FLORIDA, AS FOLLOWS:

Section 1. That the Board of County Commissioners does hereby establish the following insurance requirements for Escambia County Solid Waste Management Permit holders:

- (A) Insurers. The contractors shall procure and maintain required insurance coverages documented on Certificates of Insurance which show policies with insurers with a Secure A. M. Best rating and a financial rating size of "VII" or better, as published by the most recent edition of the A.M. Best rating guide.
- (B) Certificates of Insurance. Except for worker's compensation, Escambia County shall be an additional insured under these policies. The insurance coverages and limits required must be evidenced by properly executed certificates of insurance submitted to the Department of Solid Waste Management at least seven (7) days before the Contractor commences work. Certificates of Insurance must expressly evidence that the Contractor's policies have been endorsed to give Escambia County at least thirty (30) days advance notice before any cancellation or reduction in insurance coverage takes effect.
- (C) Commercial General Liability. Contractor shall maintain a commercial general liability insurance policy with minimum limits of coverage in the amount of One Million Dollars (\$1,000,000), per occurrence/aggregate, including coverage parts of bodily injury, personal injury and death, broad form property damage, blanket contractual liability covering the contract, independent contractors, premises/operations, products and completed operations, and fire legal liability.

- (D) **Automobile Liability.** Coverage shall be maintained by the Contractor at all times during the Term of the Permit with minimum limits of One Million Dollars (\$1,000,000) per occurrence for bodily injury, property damage, and death, arising out of ownership or use of any vehicles including owned, non-owned and hired vehicles and employee non-ownership use used by the Contractor in the incorporated or unincorporated areas of Escambia County.
- (E) **Worker's Compensation and Employer's Liability.** Coverage shall be maintained for worker's compensation insurance for all worker's compensation obligations imposed by state law and employer's liability limits of at least \$100,000 each accident and \$100,000 each employee/\$500,000 policy limit for disease. The other party shall also purchase any other coverages required by law for the benefit of employees.
- (F) The Contractor agrees to indemnify, defend and hold the County harmless from any and all claims, suits, demands, or judgments against the County arising out of or in any way related to the acts or omissions of the Contractor. The Contractor shall not be required to indemnify or hold the County harmless for any act or omission caused by the negligent or willful misconduct of the County.

Section 2. That this schedule of insurance requirements for Escambia County Solid Waste Management Permit holders shall take effect upon adoption by the Board of County Commissioners.



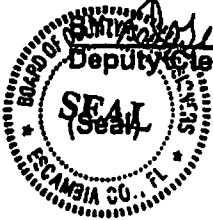
