Perdido Landfill

(a) DISPOSAL RATES -

Solid Waste:	\$ 45.06 per ton \$ 11.64 minimum
Yard Trash:	\$ 27.62 per ton \$ 11.64 minimum
Oak Grove Citizens Convenience Center Rate:	\$ 9.01 per cubic yard \$ 11.64 minimum

(Cubic Yardage of Load is determined by measuring the load)

Waste tires:	\$ 196.25 per ton
Mixed loads containing tires will be charged:	\$ 3.90 per car & light truck tire \$ 7.80 per tire larger than car and light truck tire

Clean fill, dirt, and clean concrete: NO FEE
(Clean concrete means no rebar and no welded wire fabric)

Uncovered load fee:	\$ 35.12 per commercial load
<i>(Applicable to ALL landfill customers)</i>	\$ 7.02 per individual citizen's load

(Reference Chapter 82 Code of Ordinances, §316.520 FS and 49 CFR 393.100)

(b) SPECIAL HANDLING RATES -

Asbestos:	\$ 235.47 per ton
Special Waste:	\$ 94.49 per ton
<i>(All special waste requires review, approval, and scheduling by Waste Services Department Management staff prior to acceptance.)</i>

Load ejection assistance:	\$ 113.78 per hour**
